# Academic Regulations for Three Year BBA (Data Analytics) with Effect from Academic Year 2022-23

(for B. Tech. /B. Pharmacy pursuing Students as a Second Degree Programme)

#### 1.0 <u>Under-Graduate 3 Year Degree Programme in BBA (Data Analytics)</u> Course

Jawaharlal Nehru Technological University Hyderabad (JNTUH) offers a 3-Year (6 semesters) **Bachelor of Business Administration in Data Analytics** (BBA-DA) degree programme simultaneously under Choice Based Credit System (CBCS) at its Autonomous/ Non-Autonomous, Constituent and Affiliated colleges with effect from the academic year 2022-23. This programme is designed as per UGC guidelines for pursuing two Academic Programmes simultaneously (D.O. No.1/6/2007 (CPP-II) New, Dt:13.04.2022).

#### 2.0 Eligibility and other details

- **2.1** B. Tech. (I /II / III) year pursuing students of the respective institutes affiliated to JNTUH are eligible.
- 2.2 The medium of instructions for the entire under graduate programme in Bachelor of Business Administration in Data Analytics (BBA-DA) will be in **English** only
- **2.3 Intake:** Intake is Maximum of 60 per section per college and to offer this course minimum 20 students of intake is required. If required multiples of such sections can be started.
- **2.4 Fee:** Rs. 60,000/- per Annum plus special fee of Rs. 5500/- per Annum and examination fee of Rs. 1910 per year (Rs. 955/- per semester as per JNTUH norms) and to be paid to the Principal of the respective College.
- 2.5 The Colleges Offering this programme are required to submit a letter of consent to the University for approval.
- 2.6 The registration of the students is taken by the Principal of the College and the list is to be submitted to the university before commencement of Classwork.

#### 3.0 BBA Programme structure

- 3.1 A student after securing admission shall complete the BBA programme in a minimum period of **Three** academic years (6 semesters), and a maximum period of **Six** academic years (12 Semesters) starting from the date of commencement of first year first semester, failing which student shall forfeit seat in BBA (DA) course. Each student shall secure **138** credits (with CGPA ≥ 5) required for the completion of the under graduate programme and award of the BBA degree.
- **3.2 UGC/ AICTE** specified definitions/ descriptions are adopted appropriately for various terms and abbreviations used in these academic regulations/ norms, which are listed below.

#### 3.2.1 Semester scheme

Each under graduate programme is of 3 academic years (6 semesters) with the academic year divided into two semesters of 22 weeks (≥ 90 instructional days) each, each semester having - 'Continuous Internal Evaluation (CIE)' and 'Semester End Examination (SEE)' under Choice Based Credit System (CBCS) and Credit Based Semester System (CBSS) indicated by UGC, and curriculum/course structure as suggested by AICTE are followed.

#### 3.2.2 Credit courses

All subjects/ courses are to be registered by the student in a semester to earn credits which shall be assigned to each subject/ course in an L: T: P: C (lecture periods: tutorial periods: practical periods: credits) structure based on the following general pattern.

- One credit for one hour/ week/ semester for theory/ lecture (L) courses or Tutorials.
- One credit for two hours/ week/ semester for laboratory/ practical (P) courses.

#### 4.0 Course registration

- 4.1 A 'faculty advisor or counselor' shall be assigned to a group of 20 students, who will advise the students about the under graduate programme, its course structure and curriculum, choice/option for subjects/ courses, based on their competence, progress, prerequisites and interest.
- 4.2 The academic section of the college invites 'registration forms' from students before the beginning of the semester through 'on-line registration', ensuring 'date and time stamping'. The on-line registration requests for any 'current semester' shall be completed before the commencement of SEEs (Semester End Examinations) of the 'preceding semester'.
- 4.3 A student can apply for **on-line** registration, **only after** obtaining the 'written approval' from faculty advisor/counselor, which should be submitted to the college academic section through the Head of the Department. A copy of it shall be retained with Head of the Department, faculty advisor/ counselor and the student.
- **4.4** If the student submits ambiguous choices or multiple options or erroneous entries during **on-line** registration for the subject(s) / course(s) under a given/ specified course group/

- category as listed in the course structure, only the first mentioned subject/ course in that category will be taken into consideration.
- 4.5 Subject/ course options exercised through **on-line** registration are final and **cannot** be changed or inter-changed; further, alternate choices also will not be considered. However, if the subject/ course that has already been listed for registration by the Head of the Department in a semester could not be offered due to any unforeseen or unexpected reasons, then the student shall be allowed to have alternate choice either for a new subject (subject to offering of such a subject), or for another existing subject (subject to availability of seats). Such alternate arrangements will be made by the head of the department, with due notification and time-framed schedule, within the **first week** after the commencement of class-work for that semester.
- **4.6** Dropping of subjects/ courses may be permitted, only after obtaining prior approval from the faculty advisor/ counselor 'within a period of 15 days' from the beginning of the current semester.
- **4.7 Open Electives**: The students have to choose three Open Electives (OE-I & II) from the list of open electives given.

#### **5.0** Attendance requirements:

- 5.1 A student shall be eligible to appear for the semester end examinations, if the student acquires a minimum of 75% of attendance in aggregate of all the subjects/ courses (including attendance in mandatory courses like Environmental Science, Constitution of India, Intellectual Property Rights, and Gender Sensitization lab) for that semester. Two periods of attendance for each theory subject shall be considered, if the student appears for the mid-term examination of that subject. This attendance should also be included in the fortnightly upload of attendance to the University.
- 5.2 Shortage of attendance in aggregate up to 10% (65% and above, and below 75%) in each semester may be condoned by the college academic committee on genuine and valid grounds, based on the student's representation with supporting evidence.
- **5.3** A stipulated fee shall be payable for condoning of shortage of attendance.
- **5.4** Shortage of attendance below 65% in aggregate shall in **NO** case be condoned.
- 5.5 Students whose shortage of attendance is not condoned in any semester are not eligible to take their end examinations of that semester. They get detained and their registration for that semester shall stand cancelled, including all academic credentials (internal marks etc.) of that semester. They will not be promoted to the next semester. They may seek re-registration for all those subjects registered in that semester in which the student is detained, by seeking re-admission into that semester as and when offered; if there are any professional electives and/ or open electives, the same may also be re-registered if offered. However, if those electives are not offered in later semesters, then alternate electives may be chosen from the same set of elective subjects offered under that category.

**5.6** A student fulfilling the attendance requirement in the present semester shall not be eligible for readmission into the same class.

#### 6.0 Academic requirements

The following academic requirements have to be satisfied, in addition to the attendance requirements mentioned in Item No.5.

- A student shall be deemed to have satisfied the academic requirements and earned the credits allotted to each subject/ course, , if student secures not less than 35% (14 marks out of 40 marks) in the internal examinations, not less than 35% (21 marks out of 60 marks) in the semester end examination, and a minimum of 40% (40 marks out of 100 marks) in the sum total of the CIE (Continuous Internal Evaluation) and SEE (Semester End Examination) taken together; in terms of letter grades, this implies securing 'C' grade or above in that subject/ course.
- A student shall be deemed to have satisfied the academic requirements and earned the credits allotted to **Summer Internship-I** (**Social Responsibility Project**), if the student secures not less than 40% marks (i.e. 20 out of 50 allotted marks). The student is deemed to have failed, if he (i) does not submit a report on **Summer Internship**, or does not make a presentation of the same before the evaluation committee as per schedule, or (iii) secures less than 40% marks in **Summer Internship I** evaluations.

A student shall be deemed to have satisfied the academic requirements and earned the credits allotted to **Summer Internship – II (Field based study in a Company (or) Public Sector (or) NGO)**, if the student secures not less than 40% marks (i.e. 20 out of 50 allotted marks). The student is deemed to have failed, if he (i) does not submit a report on **Summer Internship - II**, or does not make a presentation of the same before the evaluation committee as per schedule, or (iii) secures less than 40% marks in **Summer Internship - II** evaluations.

A student may reappear once for each of the above evaluations, when they are scheduled again; if the student fails in such 'one reappearance' evaluation also, the student has to reappear for the same in the next subsequent semester, as and when it is scheduled.

- 6.3 A student (i) shall register for all courses/subjects covering 138 credits as specified and listed in the course structure, (ii) fulfills all the attendance and academic requirements for 138 credits, (iii) earn all 138 credits by securing SGPA ≥ 5.0 (in each semester), and CGPA (at the end of each successive semester) ≥ 5.0, (iv) passes all the mandatory courses, to successfully complete the under graduate programme. The performance of the student in these 138 credits shall be considered for the calculation of 'the final CGPA (at the end of under graduate programme), and shall be indicated in the grade card of IV-year II semester.
- A student eligible to appear in the semester end examination for any subject/ course, but absent from it or failed (thereby failing to secure 'C' grade or above) may reappear for that subject/ course in the supplementary examination as and when conducted. In

such cases, internal marks (CIE) assessed earlier for that subject/ course will be carried over, and added to the marks to be obtained in the SEE supplementary examination for evaluating performance in that subject.

A student detained in a semester due to shortage of attendance may be re-admitted in the same semester in the next academic year for fulfillment of academic requirements. The academic regulations under which a student has been readmitted shall be applicable. However, no grade allotments or SGPA/ CGPA calculations will be done for the entire semester in which the student has been detained.

#### 7.0 Evaluation - Distribution and Weightage of marks

- 7.1 The performance of a student in every subject/course (including practicals and Project Stage I & II) will be evaluated for 100 marks each, with 40 marks allotted for CIE (Continuous Internal Evaluation) and 60 marks for SEE (Semester End-Examination).
- 7.2 In CIE, for theory subjects, during a semester, there shall be two mid-term examinations. Each Mid-Term examination consists of two parts i) **Part A** for 10 marks, ii) **Part B** for 20 marks with a total duration of 2 hours as follows:
  - 1. Mid-Term Examination for 30 marks:
    - a. Part A: Objective/quiz paper for 10 marks.
  - b. Part B: Descriptive paper for 20 marks. (4 questions out of 6 questions) The remaining 10 marks are for Continuous Internal Assessment (out of 40 marks) and are distributed as:
    - 2. Assignment for 5 marks. (Average of 2 Assignments each for 5 marks)
    - 3. PPT presentation/ group discussion/ role plays/ best practices in an organization Case study (or) Survey (or) Team based presentations on a topic in the concerned subject for 5 marks before II Mid-Term Examination.
  - The objective/quiz paper is set with multiple choice, fill-in the blanks and matching type of questions for a total of 10 marks. The descriptive paper shall contain 6 full questions out of which, the student has to answer 4 questions, each carrying 5 marks. The average of two Mid-Term examinations is considered for 30 marks.

While the first mid-term examination shall be conducted on 50% of the syllabus, the second mid-term examination shall be conducted on the remaining 50% of the syllabus.

Five (5) marks are allocated for assignments (as specified by the subject teacher concerned). The first assignment should be submitted before the conduct of the first mid-term examination, and the second assignment should be submitted before the conduct of the second mid-term examination. The average of the two assignments shall be taken as the final marks for assignment (for 5 marks).

• The Student, in each subject, shall have to earn 35% of marks (i.e. 14 marks out of 40 marks) in CIE, 35% of marks (i.e. 21 marks out of 60) in SEE and Overall 40% of marks (i.e. 40 marks out of 100 marks) both CIE and SEE marks put together.

The student is eligible to write Semester End Examination of the concerned subject, if the student scores  $\geq 35\%$  (14 marks) of 40 Continuous Internal Examination (CIE) marks.

In case, the student appears for Semester End Examination (SEE) of the concerned subject but not scored minimum 35% of CIE marks (14 marks out of 40 internal marks), his performance in that subject in SEE shall stand cancelled inspite of appearing the SEE.

There is NO Computer Based Test (CBT) for R22 regulations.

The details of the end semester question paper pattern are as follows:

- **7.2.1** The Semester End Examinations (SEE), for Theory courses, will be conducted for 60 marks consisting of two parts viz. i). **Part-A** for 10 marks, ii). **Part-B** for 50 marks.
  - Part-A is a compulsory question consisting of ten sub-questions from all units carrying equal marks.
  - Part-B consists of five questions (numbered from 2 to 6) carrying 10 marks each. Each of these questions is from each unit and may contain sub-questions. For each question there will be an "either" "or" choice, which means that there will be two questions from each unit and the student should answer either of the two questions.
  - The duration of Semester End Examination is 3 hours.
- **7.3** For practical subjects there shall be a Continuous Internal Evaluation during the semester for 40 marks and 60 marks for Semester End Examination. Out of the 40 marks for internal evaluation:
  - 1. The experiments/programs in the laboratory shall be evaluated for 15 marks
  - 2. 15 marks for viva voce (or) tutorial (or) case study (or) application of the concerned course.
  - 3. Internal practical examination shall be evaluated for 10 marks conducted by the laboratory teacher concerned.

The practical Semester End Examination shall be conducted with an external examiner and the laboratory teacher. The external examiner shall be appointed from the cluster (or) other colleges which are decided by the examination branch of the University.

Out of the 60 marks for practical Semester End Examination for 3 hours:

- 1. 10 marks for write-up
- 2. 20 for experiment/program
- 3. 10 for evaluation of results
- 4. 10 marks for presentation
- 5. 10 marks for viva-voce

• The Student in each subject shall have to earn 35% of marks (i.e. 14 marks out of 40 marks) in CIE, 35% of marks (i.e. 21 marks out of 60) in SEE and Overall 40% of marks (i.e. 40 marks out of 100 marks) both CIE and SEE marks put together).

The student is eligible to write Semester End Examination of the concerned subject, if the student scores  $\geq 35\%$  (14 marks) of 40 Continuous Internal Examination (CIE) marks.

In case, the student appears for Semester End Examination (SEE) of the concerned subject but not scored minimum 35% of CIE marks (14 marks out of 40 internal marks), his performance in that subject in SEE shall stand cancelled inspite of appearing the SEE.

There is NO Computer Based Test (CBT) for R22 regulations.

- 7.4 There shall be a *Social responsibility report and Internship Field based Project in a company/ Public sector/ NGO during summer vacation* at reputed organization or in collaboration with an industry of their specialization. Students shall register for this immediately after I-Year II Semester examinations and pursue it during summer vacation / during II Year without effecting regular course work. Internship at reputed organization shall be submitted in a report form and presented before the committee in II-Year II Semester before end semester examination. It shall be evaluated for 20 internal marks during the project and 30 for external marks. The committee consists of Head of the department, supervisor and a senior faculty member of the department.
- 7.5 There shall be a Summer Internship I at reputed organization / industry. Students shall register for this immediately after I Year II Semester examinations and pursue it during summer vacation / semester break and during II Year I Semester without effect of regular course work. Summer Internship I at reputed organization / industry shall be submitted in a report form and presented before the committee in II-year I semester before end semester examination. It shall be evaluated for 50 internal marks. The committee consists of Head of the department, supervisor of the Internship, internal supervisor and a senior faculty member of the department.

There shall be NO external marks for Summer Internship -I and the student have to secure not less than 40% marks (i.e. 20 out of 50 allotted internal marks).

7.6 There shall be a Summer Internship - II at reputed organization / industry. Students shall register for this immediately after I - Year II Semester examinations and pursue it during summer vacation / semester break and during II - Year II Semester without effect of regular course work. Summer Internship - II shall be submitted in a report form and presented before the committee in II - Year II Semester before end semester examination. The external examiner shall evaluate the Summer Internship - II for 30 marks and the internal project committee shall evaluate it for 20 marks. Out of 20 internal marks, the departmental committee consisting of Head of the Department, project supervisor and a senior faculty member shall evaluate the project work for 10 marks and project supervisor shall evaluate for 10 marks.

- 7.7 The UG project shall be initiated at the end of the III Year I Semester II Mid examinations and the duration of the project work is one semester. The student must present in Project Work Review I, in consultation with his Supervisor, the title, objective and plan of action of his Project work to the departmental committee for approval before commencement of III-year II Semester. Only after obtaining the approval of the departmental committee the student can start his project work.
- 7.8 UG Project Work shall be carried out in two stages: Project Work Stage I for approval of project before Mid-II examinations in III Year I Semester and Project Work Stage II during III Year II Semester. Student has to submit project work report at the end of III Year II semester. The project shall be evaluated for 100 marks before commencement of SEE Theory examinations.
- 7.9 For Project work Stage I, the departmental committee consisting of Head of the Department, project supervisor and a senior faculty member shall approve the project work to begin at III Year I Semester. The student is deemed to be not eligible to register for the Project work, if he does not submit a report on Project Stage I or does not make a presentation of the same before the evaluation committee as per schedule.
  - A student who has failed may reappear once for the above evaluation, when it is scheduled again; if he fails in such 'one reappearance' evaluation also, he has to reappear for the same in the next subsequent semester, as and when it is scheduled.
- 7.10 For Project Work Stage II, the committee shall evaluate the project work for 100 marks. The committee consists of External examiner, Head of the department, and internal supervisor of the department. The topics for Summer Internship I, Summer Internship II and Project work shall be different from the topic already taken. The student is deemed to have failed, if he (i) does not submit a report on Project Work, or does not make a presentation of the same before the external examiner as per schedule, or (ii) secures less than 40% marks in the sum total of 100 marks.

For conducting viva-voce of project, University selects an external examiner from the list of experts in the relevant branch submitted by the Principal of the College.

A student who has failed may reappear once for the above evaluation, when it is scheduled again; if student fails in such 'one reappearance' evaluation also, he has to reappear for the same in the next subsequent semester, as and when it is scheduled.

# 7.11 A candidate shall be given only one time chance to re-register and attend the classes for a maximum of two subjects in a semester:

 If the internal marks secured by a student in the Continuous Internal Evaluation marks for 40 (Sum of average of two mid-term examinations consisting of Objective & descriptive parts, Average of two Assignments & Subject Vivavoce/PPT/ Poster presentation/ Case Study on a topic in the concerned subject) are less than 35% and failed in those subjects.

A student must re-register for the failed subject(s) for 40 marks within four weeks of commencement of the classwork in next academic year.

In the event of the student taking this chance, his Continuous Internal Evaluation marks for 40 and Semester End Examination marks for 60 obtained in the previous attempt stand cancelled.

#### **8** Grading procedure

- 8.1 Grades will be awarded to indicate the performance of students in each theory subject, laboratory / practicals/ Industry Oriented Mini Project/Internship and project. Based on the percentage of marks obtained (Continuous Internal Evaluation plus Semester End Examination, both taken together) as specified in item 8 above, a corresponding letter grade shall be given.
- As a measure of the performance of a student, a 10-point absolute grading system using the following letter grades (as per UGC/AICTE guidelines) and corresponding percentage of marks shall be followed:

- **8.3** A student who has obtained an '**F**' grade in any subject shall be deemed to have '**failed**' and is required to reappear as a 'supplementary student' in the semester end examination, as and when offered. In such cases, internal marks in those subjects will remain the same as those obtained earlier.
- 8.4 To a student who has not appeared for an examination in any subject, 'Ab' grade will be allocated in that subject, and he is deemed to have 'Failed'. A student will be required to reappear as a 'supplementary student' in the semester end examination, as and when offered next. In this case also, the internal marks in those subjects will remain the same as those obtained earlier.
- A letter grade does not indicate any specific percentage of marks secured by the student, but it indicates only the range of percentage of marks.

8.6 A student earns Grade Point (GP) in each subject/ course, on the basis of the letter grade secured in that subject/ course. The corresponding 'Credit Points' (CP) are computed by multiplying the grade point with credits for that particular subject/ course.

- 8.7 A student passes the subject/ course only when  $GP \ge 5$  ('C' grade or above)
- 8.8 The Semester Grade Point Average (SGPA) is calculated by dividing the sum of credit points ( $\Sigma$ CP) secured from all subjects/ courses registered in a semester, by the total number of credits registered during that semester. SGPA is rounded off to **two** decimal places. SGPA is thus computed as

**SGPA** = 
$$\{\sum_{i=1}^{N} C_i G_i\}/\{\sum_{i=1}^{N} C_i\}$$
 .... For each semester,

where 'i' is the subject indicator index (considering all subjects in a semester), 'N' is the no. of subjects '**registered**' for the semester (as specifically required and listed under the course structure of the parent department),  $C_i$  is the no. of credits allotted to the  $i^{th}$  subject, and  $G_i$  represents the grade points (GP) corresponding to the letter grade awarded for that  $i^{th}$  subject.

**8.9** The Cumulative Grade Point Average (CGPA) is a measure of the overall cumulative performance of a student in all semesters considered for registration. The CGPA is the ratio of the total credit points secured by a student in **all** registered courses (of 138) in **all** semesters, and the total number of credits registered in **all** the semesters. CGPA is rounded off to **two** decimal places. CGPA is thus computed from the I year II semester onwards at the end of each semester as per the formula

CGPA = 
$$\{\sum_{j=1}^{M} C_j G_j \} / \{\sum_{j=1}^{M} C_j \}$$
 ... for all S semesters registered (i.e., up to and inclusive of S semesters,  $S \ge 2$ ),

where 'M' is the **total** no. of subjects (as specifically required and listed under the course structure of the parent department) the student has '**registered**' i.e., from the  $1^{st}$  semester onwards up to and inclusive of the  $8^{th}$  semester, 'j' is the subject indicator index (takes into account all subjects from 1 to 8 semesters),  $C_j$  is the no. of credits allotted to the  $j^{th}$  subject, and  $G_j$  represents the grade points (GP) corresponding to the letter grade awarded for that  $j^{th}$  subject. After registration and completion of I year I semester, the SGPA of that semester itself may be taken as the CGPA, as there are no cumulative effects.

- **8.10** For merit ranking or comparison purposes or any other listing, **only** the '**rounded off**' values of the CGPAs will be used.
- **8.11** SGPA and CGPA of a semester will be mentioned in the semester Memorandum of Grades if all subjects of that semester are passed in first attempt. Otherwise the SGPA and CGPA shall be mentioned only on the Memorandum of Grades in which sitting he passed his last exam in that semester. However, mandatory courses will not be taken into consideration.

#### 9.0 Passing standards

- 9.1 A student shall be declared successful or 'passed' in a semester, if he secures a  $GP \ge 5$  ('C' grade or above) in every subject/course in that semester (i.e. when the student gets an  $SGPA \ge 5.00$  at the end of that particular semester); and he shall be declared successful or 'passed' in the entire under graduate programme, only when gets a CGPA  $\ge 5.00$  ('C' grade or above) for the award of the degree as required.
- 9.2 After the completion of each semester, a grade card or grade sheet shall be issued to all the registered students of that semester, indicating the letter grades and credits earned. It will show the details of the courses registered (course code, title, no. of credits, grade earned, etc.) and credits earned. There is NO exemption of credits in any case.

#### 9.3 Declaration of results

- **9.4** Computation of SGPA and CGPA are done using the procedure listed in 9.6 to 9.9.
- **9.5** For final percentage of marks equivalent to the computed final CGPA, the following formula may be used.

% of Marks = 
$$(\text{final CGPA} - 0.5) \times 10$$

#### 10.0 Award of degree

- **10.1** A student who registers for all the specified subjects/ courses as listed in the course structure and secures the required number of 138 credits (with CGPA ≥ 5.0), within 8 academic years from the date of commencement of the first academic year, shall be declared to have 'qualified' for the award of B.Tech. degree in the chosen branch of Engineering selected at the time of admission.
- **10.2** A student who qualifies for the award of the degree as listed in item 12.1 shall be placed in the following classes.
- 10.3 A student with final CGPA (at the end of the under graduate programme) > 7.00, and fulfilling the following conditions shall be placed in 'First Class with Distinction'. However, he
  - (i) Should have passed all the subjects/courses in 'First Appearance' within the first 4 academic years (or 8 sequential semesters) from the date of commencement of first year first semester.
  - (ii) Should not have been detained or prevented from writing the semester end examinations in any semester due to shortage of attendance or any other reason.

A student not fulfilling any of the above conditions with final CGPA > 7 shall be placed in 'First Class'.

- Students with final CGPA (at the end of the under graduate programme) ≥ 7. 0 but <</li>8.00 shall be placed in 'First Class'.
- 10.5 Students with final CGPA (at the end of the under graduate programme)  $\geq$  6.0 but < 7.0, shall be placed in 'Second Class'.

- 10.6 All other students who qualify for the award of the degree (as per item 12.1), with final CGPA (at the end of the under graduate programme)  $\geq 5.00$  but < 6.0, shall be placed in 'Pass Class'.
- **10.7** A student with final CGPA (at the end of the under graduate programme) < 5.00 will not be eligible for the award of the degree.
- 10.8 Students fulfilling the conditions listed under item 12.3 alone will be eligible for award of 'Gold Medal'.

#### 11.0 Withholding of results

11.1 If the student has not paid the fees to the University at any stage, or has dues pending due to any reason whatsoever, or if any case of indiscipline is pending, the result of the student may be withheld, and the student will not be allowed to go into the next higher semester. The award or issue of the degree may also be withheld in such cases.

#### 11.2 Student transfers

- 11.3 There shall be no branch transfers after the completion of admission process.
- 11.4 There shall be no transfers from one college/stream to another within the constituent colleges and units of Jawaharlal Nehru Technological University Hyderabad.
- 11.5 The students seeking transfer to colleges affiliated to JNTUH from various other Universities/institutions have to pass the failed subjects which are equivalent to the subjects of JNTUH, and also pass the subjects of JNTUH which the students have not studied at the earlier institution. Further, though the students have passed some of the subjects at the earlier institutions, if the same subjects are prescribed in different semesters of JNTUH, the students have to study those subjects in JNTUH in spite of the fact that those subjects are repeated.
- 11.6 The transferred students from other Universities/institutions to JNTUH affiliated colleges who are on rolls are to be provided one chance to write the CBT (for internal marks) in the **equivalent subject(s)** as per the clearance letter issued by the University.
- 11.7 The autonomous affiliated colleges have to provide one chance to write the internal examinations in the **equivalent subject(s)** to the students transferred from other universities/institutions to JNTUH autonomous affiliated colleges who are on rolls, as per the clearance (equivalence) letter issued by the University.

#### **16.0** Scope

- **16.1** The academic regulations should be read as a whole, for the purpose of any interpretation.
- 16.2 In case of any doubt or ambiguity in the interpretation of the above rules, the decision of the Vice-Chancellor is final.

- 16.3 The University may change or amend the academic regulations, course structure or syllabi at any time, and the changes or amendments made shall be applicable to all students with effect from the dates notified by the University authorities.
- **16.4** Where the words "he", "him", "his", occur in the regulations, they include "she", "her", "hers".
